LITIGATION AND LEGISLATIVE ACTIVITIES

I have handled two merits cases in the U.S. Supreme Court.

In Schenck v. Pro-Choice Network, 117 S.Ct. 855 (1997), I was lead counsel for plaintiffs/respondents, and I briefed and argued the case. I started this case in the U.S. District Court for the W.D.N.Y. in 1990, and served as lead counsel in all proceedings in the district court, as well as two Second Circuit appeals, including an en banc, and related contempt proceedings and appeals. The case involved an injunction setting locational limits on protest activities at women's health clinics, and became a major First Amendment case in the U.S. Supreme Court that is referenced in many constitutional law casebooks and civil rights teaching materials.

In *U.S. v. Burke*, No. 91-42 (1991), a case involving the taxability of Title VII employment discrimination back-pay awards, I wrote the brief and was co-counsel with my father, who argued the case. This significant tax case has been included in many tax law casebooks and teaching materials.

In the U.S. Supreme Court I have also written several *amicus curiae* briefs, and have also written successful briefs in opposition to certiorari. I have also authored *amicus* briefs in state high courts on tort, products liability, and reproductive rights issues.

In addition to my U.S. Supreme Court work, I have briefed and argued numerous federal appeals in the 1st, 2nd, D.C., 6th, and 11th Circuits, on issues ranging from injunctions curtailing protest activity at women's health clinics, employment discrimination, labor law, banking law, and federal criminal law.

I have appeared as an expert witness in court cases challenging, on state and federal constitutional grounds, tort damage cap laws. My expert witness role is based on my academic research, and has included affidavits as well as live testimony. These

appearances range from Nova Scotia, Canada, to Florida, Maryland, Nevada, Kansas, Georgia, Missouri, Louisiana, and Illinois.

I have also provided legislative testimony to the House and Senate of the U.S. Congress, on issues including products liability reform and the impact on women, and on access to reproductive health clinics. I have also testified before several state legislative committees or administrative commissions on issues including tort reform, medical malpractice, gender equity, family and medical leave.
